MINNESOTA WILL BE FIRST IN THE NATION TO OFFER ADVANCE PAYMENTS OF THE CHILD TAX CREDIT

Minnesota Budget Project, along with Governor Tim Walz and other tax advocates, reached out to Minnesotan families with kids that could qualify for the state's new Child Tax Credit (CTC). In its first year, more than **450,000 children have already benefitted** from the more than **half a billion dollars that was sent to families** across Minnesota thanks to the nation-leading CTC.

Next year, we're redoubling our efforts to reach even more families about the incomeboosting tax credit. Minnesota will be the **first state to offer advance payments of the CTC**. Advance payments will give eligible families the option to receive a portion of their tax credit on a schedule that better fits their budgets and gets money in their pockets sooner to afford food, diapers, and other basic necessities of raising thriving kids.

POLICY FOCUS ARE FEDERAL THREATS TO MINNESOTANS AND THE NEXT STATE BUDGET

Next year will bring significant threats on the federal level. We and our partners have already begun to identify specific avenues through which federal policymakers may shrink critical public services, like health care and food assistance. We also know that top priorities of the incoming administration are to extend large tax cuts that primarily benefit the nation's wealthiest households and profitable corporations. Those large tax cuts would cut deeply into federal revenues, further threatening critical public services, like education or child care.

The Minnesota Budget Project, in partnership with national and state allies, is well positioned to participate in robust defense against threats to Minnesotans' health and well-being. We hope you'll join in that advocacy in the coming months.

For the state of Minnesota, 2025 is a budget-setting year, and we'll continue our practice of arming partners and advocates with the information they need to influence essential policy and budget decisions, especially given the more challenging state budget landscape.

Minnesota policymakers will have to respond to whatever federal funding cuts and policy changes will flow through to the state in months and years to come, and we'll be advocating that they prioritize Minnesotans' health and economic security as they do. Federal funding cuts to health care or food assistance will result in drastic hardship for Minnesotans. Federal decisions also threaten funding to the state for essential services; the state receives billions of federal dollars for Medicaid alone, for example.
